Rental of the Crowfield Country Club pool for the date and time set forth above shall be \$275 using the ENTIRE POOL exclusively. A \$100 security deposit is required and will be returned to renter via mail if there are no damages to the facility or contract violations.

The Recreation Department shall provide two lifeguards for a rental (50 person max).

The undersigned acknowledges that any activities at the pool carry the risk of injury, including but not limited to falls, slips, crashes and collisions that may result in personal injury and/or property damage.

The undersigned acknowledges and represents that it has appropriate homeowner and/or liability insurance in effect to cover claims for injuries or damage that may arise by virtue of the use of the facility and activities.

The undersigned agrees to indemnify and hold harmless the City of Goose Creek, its agents, employees, officers, officials, and successors and assigns from any and all claims demands, actions, or causes of actions for personal injury or property damage or any other loss that arises or is to arise from the use of the swimming pool by the undersigned or by any of the undersigned's guests, invitees, agents, servants, and employees.

A cancellation made seven (7) or more calendar days prior to the day of the rental will result in a refund, less a 50% handling fee. Cancellations made less than seven (7) days prior to the day of the rental will result in forfeiture of the entire rental fee.

The undersigned, by affixing his/her signature to this rental agreement, acknowledges having read and understood the rental agreement and consents to the terms of the rental agreement.

Pool Party Rental Rules

1. Amount must be paid in full two weeks prior to rental.
2. **A security deposit is required on every rental.** The deposit will be refunded if there are no damages or contract violations. Refunds will be mailed within 30 days after party.
3. Pool area must be vacated by the time specified on your contract.
4. **One (1) chaperone per 10 children (persons under the age of 18)** must accompany each group.
5. Swimmers must follow the pool rules and the directive of the lifeguard(s) on duty.
6. Renter is responsible for any damages caused to facility during time of rental.
7. Renter is responsible for making sure the pool area is clean before leaving. **ALL TRASH MUST BE PICKED UP.** If the facility is not cleaned up, your deposit will be forfeited.
8. No excessively loud music is permitted.
9. No smoking, no alcoholic beverages, no use of offensive or inappropriate language.
10. No possession of firearms, knives or any type of weapons,
11. No possession or use of drugs.
12. No animals, except service dogs.
13. The rental of the pool is for the benefit of private individuals; no fundraising, commercial activity, religious or anti-religious activity allowed or any use for which the City of Goose Creek determines is not consistent with the mission of the City.
14. Failure to comply with any other rules established by the Recreation Department or lifeguard (s) will result in dismissal from the pool. If the event is ended for cause, no refund will be issued.
